WHEREAS, Republic Act No. 11223, otherwise known as the Universal Health Care (UHC) Act of 2019, has been enacted to make available commensurate financial and non-financial matching grants, human resources for health and health commodities, to improve the functionality of province-wide health system;

WHEREAS, the Fourmula One Plus for Health is a strategic framework for Health Sector Reform to attain the goals outlined by the Philippine Government in the Philippine Development Plan, the Sustainable Development Goals, and the Ambisyon Natin 2040;

WHEREAS, for consistent, efficient, and quality medical services to Isabeleños, the Provincial Government of Isabela has agreed to enter into a Terms of Partnership with the Department of Health-Center for Health Development (DOH-CHD) Cagayan Valley;

WHEREAS, under the aforesaid Partnership, PGI agreed to implement health sector reforms which is consistent with the Universal Health Care Act and the Fourmula One Plus for Health and shall receive an estimated allocation of Two Million Seven Hundred Twenty Six Thousand Six Hundred Sixty Five Pesos (P 2,726,665.00) support (Financial and Non-Financial Grants);

WHEREAS, under Section 465, (b) (vi) of R. A. No. 7160, the Provincial Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Terms of Partnership on behalf of the Provincial Government of Isabela;

WHEREAS, premises considered, upon motion of Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –
