WHEREAS, the Universal Health Care (UHC) Act of 2019 has been enacted to progressively realize universal health care in the country through a systematic approach and a clear delineation of roles of key agencies and stakeholders towards better performance in the health system;

WHEREAS, under the aforesaid Act, every Local Government Units (LGUs) are given a six-year transition period to commit into a province-wide and city-wide integration, wherein managerial and technical integration is expected to be demonstrated in the first three years (2020-2022) and the financial integration to be exhibited within the next three years (2023-2025);

WHEREAS, an integrated province-wide health system is a strategy where systems of DOH and Philhealth are incorporated to provide technical and financial support to local government units in order to sustain a quality health care at all levels of the health system;

WHEREAS, the Provincial Government of Isabela resolves to enter into a Memorandum of Understanding with the DOH and Philhealth to implement the Universal Health Act on Integration of Health System and to facilitate the fulfilment of the activities, outputs, and outcomes for the success of an integrated province-wide system that delivers effective and efficient services for seamless, high quality, and affordable health care;

WHEREAS, under Section 465, (b) (1) (vi) of R. A. No. 7160, the Provincial Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Memorandum of Understanding on behalf of the Provincial Government of Isabela;

WHEREAS, premises considered, upon motion of Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was -
