WHEREAS, Ms. Annaliza O. Medina, Mr. Juan Carlos O. Medina and Ramon Antonio O. Medina, members of such community, have requested the Provincial Government of Isabela to establish an easement of right of way over the 681-square meter portion of its property in Alibagu, City of Ilagan, Isabela, hereinafter referred to as *Proposed Access Road*;

WHEREAS, Ms. Annaliza O. Medina, Mr. Juan Carlos O. Medina and Ramon Antonio O. Medina, through their Attorney-in-Fact, Mr. Ramon Sheker Medina, stated that their community has no adequate outlet to a public road and that by granting their fellow landowners entry through the Proposed Access Road, they will have a more convenient and speedier access to their homes, properties, and the public road;

WHEREAS, this Honorable Body acknowledges that the establishment of an easement of right of way over the Proposed Access Road will bring significant relief to the members of such community considering that they will gain better access to their homes and the public road;

WHEREAS, in view of the absence of an adverse finding in the land inspection and on-site studies of the Provincial Assessor's Office and the Provincial Engineer's Office and the favorable response of the Provincial Governor to the request, this Honorable Body finds no ground to oppose the establishment of an easement of right-of-way over the Proposed Access Road in favor of the property owners residing behind the Provincial Capitol;

WHEREFORE, premises considered, upon motion of Hon. Marco Paolo A. Meris, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION INTERPOSING NO OBJECTION TO THE CONSTITUTION OF AN EASEMENT OF RIGHT OF WAY OVER THE 681-SQUARE METER PORTION OF THE PROPERTY OF THE PROVINCIAL GOVERNMENT OF ISABELA LOCATED IN ALIBAGU, CITY OF ILAGAN, ISABELA

RESOLVED FURTHER, that the grant of right of easement of right of way over the Proposed Access Road in favor of the said property owners is subject to the execution of the necessary instrument between the appropriate parties.

RESOLVED FINALLY, that a copy of this Resolution be furnished to the Provincial Governor, Honorable Rodolfo T. Albano III, for his guidance and further action; and Mr. Ramon Sheker Medina for his information.
