WHEREAS, submitted before this Honorable Body is a Memorandum of Agreement (MOA) between the PGI, DOH-CVCHD, and Mr. Marvin R. Valiente. The accomplishment of this MOA is necessary for the realization of the said epidemiology training;

WHEREAS, after careful review of the MOA, this Honorable Body finds the same to be just, lawful, in line with the health policies and priorities of the PGI, and is advantageous to Isabeleños;

WHEREAS, Section 465, par. (b)(1)(vi) of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;
