A RESOLUTION APPROVING AND ADOPTING THE UPDATED LOCAL ROAD NETWORK DEVELOPMENT PLAN OF THE PROVINCE OF ISABELA FOR YEARS 2021 TO 2025

WHEREAS, Sections 17(a) and 17(b)(3)(vii) of the Local Government Code (LGC) mandates Local Government Units (LGUs) to provide basic services and facilities, including infrastructure such as roads and bridges;

WHEREAS, Section 17(f) of the LGC, however, provides that the National Government may augment the basic services and facilities to an LGU when these are inadequate to meet the requirements of its inhabitants;

WHEREAS, the Conditional Matching Grant to Provinces (CMGP) Program is a National Government initiative that aims to improve the state of core provincial roads. The Program addresses challenges in road management in the provinces, leading to poor local road conditions that hamper mobility, connectivity of road networks, and economic development at the local level;

A RESOLUTION APPROVING AND ADOPTING THE UPDATED LOCAL ROAD NETWORK DEVELOPMENT PLAN OF THE PROVINCE OF ISABELA FOR YEARS 2021 TO 2025

WHEREAS, the Province of Isabela is a recipient of and partner of the National Government in the implementation of the CMGP Program for Road, Repair, Rehabilitation, and Improvement;

WHEREAS, DILG Memorandum Circular No. 2017-159 mandates all Provincial Local Government Units to prepare or update their Local Road Network Development Plan (LRNDP) in collaboration with the city and municipal governments, business sector organizations and other stakeholders with particular emphasis on the sustainability of the development and management not only of provincial roads but all local road network aimed at spurring economic activities and improving public access to infrastructure and economic services;

WHEREAS, the LRNDP is an integrated 5-year development plan for the sustainable development and maintenance of local road networks. It is in line with the implementation of the Conditional Matching Grants to Provinces (CMGP) Program as provided for under DILG Memorandum Circular No. 2017-159;

WHEREAS, in adherence to the said DILG mandate, the Provincial Development Council collaborated with the Provincial Local Road Network Development Plan Core and Technical Working Groups, city and municipal governments in the Province of Isabela, business sector organizations and other stakeholders to update the existing Local Road Network Development Plan of the Provincial Government of Isabela;

WHEREAS, submitted for the consideration, approval, and adoption of this Honorable Body is the updated LRNDP of the Provincial Development Council for years 2021 to 2025;

WHEREAS, after careful examination of the submitted LRNDP, this Honorable Body finds the same to be compliant with the intents and purposes of the CMGP Program and DILG-DBM Joint Memorandum Circular No. 2017-159 and consistent with the existing Provincial Development and Physical Framework Plan;

WHEREFORE, premises considered, upon motion of Hon. Marco Paolo A. Meris, duly approved and seconded in a session duly assembled, it was –


