A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR, RODOLFO T. ALBANO III, ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH-CAGAYAN VALLEY CENTER FOR HEALTH DEVELOPMENT AND SAN MARIANO COMMUNITY HOSPITAL FOR THE IMPLEMENTATION OF MEDICAL ASSISTANCE TO INDIGENT PATIENTS (MAIP) PROGRAM

WHEREAS, in light of the passage of such Resolution, the Provincial Governor, Honorable Rodolfo T. Albano III, sent a Letter addressed to this Honorable Body requesting that he be granted with an authority to represent the Provincial Government of Isabela in the signing of a Memorandum of Agreement with Mr. Ramon Sheker Medina, the attorney-in-fact of Annaliza O. Medina, Juan Carlos O. Medina, and Ramon Antonio O. Medina for the constitution of a right of way over the exact property stated in the said Resolution;

WHEREAS, after careful review of the Memorandum of Agreement, this Honorable Body finds the same to be just - considering that the Medina parties are obligated to develop the subject property for purposes of establishing an access road or bridge for the benefitting public - lawful, in line with the policies of the Provincial Government of Isabela, and beneficial to the public;

WHEREAS, Section 465, par. (b)(1)(vi) of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREFORE, premises considered, upon motion of Hon. Marco Paolo A. Meris, duly approved and seconded in a session duly assembled, it was -

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T.
