ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH – CAGAYAN VALLEY CENTER FOR HEALTH DEVELOPMENT FOR THE TRANSFER OF SPECIAL RISK ALLOWANCE FUNDS IN THE AMOUNT OF PHP14,670,863.564 TO BE GRANTED TO QUALIFIED HEALTH WORKERS IN THE PROVINCE OF ISABELA

WHEREAS, in line with this policy, the Provincial Government of Isabela is committed in ensuring that Isabeleño health workers from both the public and private sectors promptly receive their rightful benefits including their Special Risk Allowances granted pursuant to Section4(h) of Republic Act No. 11494 or the "Bayanihan to Recover as One Act";

WHEREAS, submitted for the consideration of this Honorable Body is the proposed Memorandum of Agreement between the Provincial Government of Isabela and the Department of Health – Cagayan Valley Center for Health Development which will enable qualified Isabeleño healthcare workers to receive their Special Risk Allowances covering the period of December 20, 2020 to June 30, 2021;

WHEREAS, by virtue of such agreement, the Provincial Government of Isabela will receive the amount of Php14,670,863.64 which shall be then granted to eligible healthcare workers in the Province of Isabela:

WHEREAS, after careful review of the proposed Memorandum of Agreement, this Honorable Body finds the same to be just, lawful, and in line with the health policies of the Provincial Government of Isabela;

WHEREAS, Section 465, par. (b)(1)(vi) of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREFORE, premises considered, upon motion of Hon. Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was —

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T.
