WHEREAS, in 2010, he decisively won the Presidential Elections in which he obtained a record 42.08% of the total votes cast;

WHEREAS, the Philippines underwent a radical institutional transformation during his tenure as President as he implemented good governance reforms which included, among others, the reformation of the country's procurement and budgeting processes to promote efficiency, transparency, public participation, and reduce opportunities for corruption;

WHEREAS, with the private sector's increased confidence to the country's institutions and the implementation of sound and sustainable economic policies, the Philippines, during his tenure, recorded its strongest years of economic growth and stability since the 1970s. In fact, international monetary agencies then consistently recognized the Philippines as one of the fastest growing economies in Asia;

WHEREAS, President Noynoy was a key partner of the Provincial Government of Isabela in the implementation of people-centric programs, projects, initiatives, and services to Isabeleños. He actively and genuinely supported the extension of government aid to the Province's agricultural sector especially to the farmers and the calamity-stricken. He also pushed for the fulfillment of key infrastructure projects in Isabela such as, among others, the reconstruction of the Lullutan Bridge, the construction of the Cabagan-Sta. Maria Bridge and various farm-to-market roads, and the repair and widening of the portion of the Maharlika Highway connecting the cities of Santiago and Tuguegarao;

WHEREAS, his invaluable support to the Province contributed immensely to the remarkable gains and advances it achieved in the past decade. These now serve as strong and stable foundations for further growth and development of Isabela to the benefit of the current and the next generations;

WHEREAS, his policies against corruption, advocacies for the advancement of the country and the people, and his support to the Province and Isabeleños will forever be cherished and remembered;

NOW THEREFORE, upon motion of Honorable Faustino G. Dy III, duly approved and seconded in a session duly assembled, it was –
