A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A TERM SHEET FOR THE LEASE OF THREE PROPERTIES OWNED BY THE LAND BANK OF THE PHILIPPINES TO BE UTILIZED AS PALAY AND CORN WAREHOUSES

WHEREAS, palay and corn procured from marginalized farmers are stored in warehouses operated by the Provincial Government of Isabela. Considering the continuing expansion of such program, there exist a clear need for additional warehouses;

WHEREAS, the Land Bank of the Philippines agreed to lease three of its properties to the Provincial Government of Isabela that shall be utilized as palay and corn warehouses, viz:

- 1. 31,778 sq.m. lot with improvements located at Sagana, Santiago City, Isabela;
- 2. 35,120 sq.m. lot with improvements located at Nugnungan 1, Cauayan City, isabela; and
- 3. 28,445 sq.m. lot with improvements at Nungnungan 1, Cauayan City, Isabela.

WHEREAS, submitted for the review and consideration of this Honorable Body is a Term Sheet to be executed between the Provincial Government of Isabela and the Land Bank of the Philippines covering the lease of the properties mentioned above;

WHEREAS, after careful review of the Term Sheet, this Honorable Body finds the same to be just, lawful, and in line with the economic upliftment policies of the Provincial Government of Isabela for its farmers;

WHEREAS, Section 465, par. (b)(1)(vi) of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREFORE, premises considered, upon motion of Hon. Faustino U. Dy IV, duly approved and seconded in a session duly assembled, it was –
