WHEREAS, Section 20 (a) of R. A. 7160 or the Local Government Code of 1991 grants a city or municipality the power to authorize the reclassification of agricultural lands into a residential, commercial or industrial purposes and was more specifically stated as follows:

"A city or municipality may, through an ordinance passed by the sanggunian after conducting public hearings for the purpose, authorize the reclassification of agricultural

lands and provide for the manner of their utilization or disposition in the following cases: (1) when the land ceases to be economically feasible and sound for agricultural purposes as determined by the Department of Agriculture or (2) where the land shall have substantially greater economic value for residential, commercial, or industrial purposes, as determined by the sanggunian concerned."

WHEREAS, Section 56 of the LGC establishes the authority of the Sangguniang Panlalawigan to review city or municipal ordinances for the purpose of determining if such is beyond the power conferred upon the sangguniang panlungsod or sangguniang bayan;

WHEREAS, the Committee on Housing, Subdivision and Land Use Classification, after a thorough review, finds that Ordinance No. 2021-010 of the Municipality of cordon is in consonance to the mandate of the Sangguniang Bayan pursuant to Section 20(a) of the Local Government Code. Thus, the said Ordinance is within the scope of the powers conferred by law to their Sangguniang Bayan;

WHEREAS, the Committee recommended to the Body to uphold the validity of Ordinance No. 2021-010 of the Municipality of Cordon, Isabela;

WHEREAS, premises considered, upon motion of HON. ED CHRISTIAN S. GO, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT IS HEREBY RESOLVED, TO PASS A RESOLUTION UPHOLDING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 2021-010 OF THE MUNICIPALITY OF CORDON ENITLED "AN ORDINANCE RECLASSIFYING LOT NO.
