A RESOLUTION CONFIRMING THAT THE FOUR (4) HEMODIALYSIS CENTER BUILDING TO BE CONSTRUCTED IN THE MILAGROS T. ALBANO DISTRICT HOSPITAL, MANUEL A. ROXAS DISTRICT HOSPITAL, CAUAYAN DISTRICT HOSPITAL, AND ECHAGUE DISTRICT HOSPITAL WILL BE OWNED, MANAGED, AND OPERATED BY THE PROVINCIAL GOVERNMENT OF ISABELA

WHEREAS, under the said Administrative Order, for government-owned Hemodialysis Center, a Sangguniang Panlalawigan resolution evidencing ownership, management and operation of the Hemodialysis Center is required;

WHEREAS, to cater the growing needs of patients who need to undergo dialysis treatments, the PGI aims to open additional four (4) Hemodialysis Centers which will be located in the four (4) District Hospitals, to wit; Milagros T. Albano District Hospital, Manuel A. Roxas District Hospital, Cauayan District Hospital, and Echague District Hospital

WHEREAS, the said four (4) district hospitals are OWNED, MANAGED AND OPERATED by the Provincial Government of Isabela. The four (4) Hemodialysis Centers to be constructed in the said District Hospitals will likewise be OWNED, MANAGED AND OPERATED by the Provincial Government of Isabela;

WHEREAS, the Provincial Government of Isabela has never entered into a MOA or a Contract of Usufruct with any private entities for the operation and management of these health facilities;

WHEREAS, in compliance to the requirements of the DOH for the issuance of PERMIT TO CONSTRUCT (PTC) for the construction of the four (4) Hemodialysis Centers, upon motion of the HON. EMMANUEL JOSELITO B. AŇES, duly seconded and approved by all the members present in a session duly assembled, it was —

RESOLVED, AS IT HEREBY RESOLVES, TO ADOPT A RESOLUTION CONFIRMING THAT THE FOUR (4) HEMODIALYSIS CENTER BUILDING TO BE CONSTRUCTED IN THE MILAGROS T. ALBANO DISTRICT HOSPITAL, MANUEL A. ROXAS DISTRICT HOSPITAL, CAUAYAN DISTRICT HOSPITAL, AND ECHAGUE DISTRICT HOSPITAL WILL BE OWNED, MANAGED, AND OPERATED BY THE PROVINCIAL GOVERNMENT OF ISABELA
