WHEREAS, in its commitment to support other local government unit's desire to provide efficient and effective provision of basic services to its people, the PGI and the Municipal Government of Delfin Albano jointly purchased a Toyota Hiace Super Grandia, which is more particularly described as follows:

WHEREAS, the Municipal Government of Delfin Albano, Isabela has been utilizing said vehicle since July 2012 as a service vehicle;

WHEREAS, due to the limited number of service vehicles being used by the Municipality of Delfin Albano, it issued Resolution No. 021-2021, requesting for the transfer of ownership of a Toyota Hiace Super Grandia thru a Deed of Donation;

WHEREAS, the Office of the Governor recognizes the need of the Municipality of Delfin Albano for additional transportation to deliver the basic services of its constituent and hereby recommends the donation of the aforesaid vehicle;

WHEREAS, the receipt of such vehicle requires the execution of a Deed of Donation between the PGI and the Municipal Government of Delfin Albano. This document was presented before this Honorable Body for its review and approval;

WHEREAS, under Section 465, (b) (vi) of R. A. No. 7160, the Provincial Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the aforesaid Deed of Donation on behalf of the Provincial Government of Isabela;

WHEREAS, premises considered, upon motion of Honorable Marco Paolo A. Meris, duly approved and seconded in a session duly assembled, it was -
