**WHEREAS**, it is the policy of the State to protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, Section 4d of Republic Act No. 11494 or the Bayanihan to Recover as One Act, authorizes the President to exercise powers that are necessary and proper to undertake and implement COVID-19 response and recovery interventions, such as delivery of uninterrupted immunization program against vaccine preventable diseases including vaccine for COVID-19;

**WHEREAS**, to combat the COVID-19 pandemic, the national government aims to acquire vaccine to minimize, if not totally prevent the spread of the virus, by entering into an agreement with a manufacturer who is capable of manufacturing and make available sufficient vaccine for the country;

WHEREAS, the AstraZeneca UK, in partnership with Oxford University, has developed ChAdOxl nCov-19 vaccine known as AZD1222 Vaccine and committed to use its best reasonable efforts to manufacture the AZD1222 Vaccine;

WHEREAS, the AstraZeneca has committed to supply the AZD1222 Vaccine to local government units (LGUs) in the country through the NTF and the Department of Health;

WHEREAS, the PGI in response has committed to allocate portion of its budget for the purchase of the minimum doses of the AZD1222 Vaccine from AstraZeneca;

WHEREAS, to enforce the immediate acquisition of vaccine, there is a need to enter into a Memorandum of Agreement for the advance purchase of AZD1222 Vaccine;

WHEREAS, Section 465(I)(vi) of the LGC empowers the Provincial Governor to represent the Provincial Government in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREAS, premises considered, upon motion of Hon. Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was-
