WHEREAS, there is a need to acquire the services of a reputable institution capable of providing reliable and cost-effective laboratory equipment, accessories, supplies;

WHEREAS, the Office of the Provincial Governor wrote a Letter to this Honorable Body requesting for authority to enter into a Memorandum of Agreement with Sta. Ana Enterprises in which the latter shall provide the PGI with laboratory equipment, accessories, and supplies that will be deployed in the PGI Hemodialysis facility, and will also provide support services to further ensure the effective operation of such medical apparatus;

WHEREAS, this Honorable Body finds that the clauses, provisions, and other stipulations provided in the Memorandum of Agreement between the PGI and Sta. Ana Enterprises to be fair, just, and reasonable;

WHEREAS, Section 465, par. VI of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREFORE, premises considered, upon motion of Hon. Emmanuel Joselito B. Añes, duly approved and seconded in a Session duly assembled, it was –
