A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO ENTER INTO A CONTRACT OF LEASE WITH ENVIROTEST INCORPORATED FOR THE RENEWAL OF THE LEASE OF ONE-HUNDRED (100) SQUARE METER REAL PROPERTY OWNED BY THE PROVINCIAL GOVERNMENT OF ISABELA

WHEREAS, pursuant to its revenue-raising power, PGI previously entered into a Contract of Lease with Envirotest Incorporated for the lease of the said parcel of land which was exclusively used as emission testing center, with primary purpose of operating motor vehicle test, and perform such other services related to the motor vehicle emission system;

WHEREAS, the Provincial Government of Isabela and Envirotest Incorporated is desirous to renew their lease contract for the continuance of its operation for the period of January 1, 2021 to December 31, 2021;

WHEREAS, Section 465(I)(vi) of the LGC empowers the Provincial Governor to represent the Provincial Government in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREAS, upon careful review of the Contract of Lease, this Body deems it beneficial to the interests of both parties to confer the Provincial Governor the necessary authority to enter into a Contract of Lease with Envirotest Incorporated;

**WHEREFORE**, upon motion of the Hon. Alfredo V. Alili, duly seconded and approved of all the members present in a session duly assembled it was –
