WHEREAS, the Provincial Government of Isabela adopts a disaster risk reduction and management approach that is holistic, comprehensive, integrated, and proactive in lessening the socioeconomic and environmental impacts of disasters;

WHEREAS, the Provincial Government of Isabela recognizes the need to strengthen the disaster preparedness and disaster response capabilities of its coastal LGUs considering their heightened vulnerability to typhoons and storm surges, and the challenges in providing them with prompt aid and assistance during and immediately after the onslaught of calamities;

ALBANO III TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A DEED OF DONATION IN FAVOR OF THE MUNICIPAL GOVERNMENT OF DINAPIGUE, ISABELA COVERING THE DINAPIGUE MULTIPURPOSE EVACUATION CENTER, OTHER STRUCTURES AND INSTALLATIONS, MACHINERIES AND OTHER EQUIPMENT

WHEREAS, in line with this determination, the Provincial Government of Isabela aspires to transfer without cost a Multi-Purpose Evacuation Center; a Power House; a Radio Repeater; a Diesel Generator Set; Two Honda XLR200 Motorcycles; a Solar Water Purification System; and a Water Treatment Facility in favor of the Municipal Government of Dinapigue, Isabela;

WHEREAS, the transfer without cost of the above-properties can only be realized through the execution of a Deed of Donation between the Provincial Government of Isabela and the Municipal Government of Dinapigue, Isabela;

WHEREAS, Section 465, par. VI of the Local Government Code empowers the Provincial Governor to represent the Province in all its transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREAS, this Honorable Body interposes no objection to the transfer without cost of the aforesaid properties in favor of the Municipal Government of Dinapigue, Isabela considering that it will result in the improvement of their disaster preparedness and disaster response capabilities which is beneficial and advantageous to the entire Province;

WHEREFORE, premises considered, upon motion of Hon. Alfredo V. Alili, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A DEED OF DONATION IN FAVOR OF THE MUNICIPAL GOVERNMENT OF DINAPIGUE, ISABELA COVERING THE DINAPIGUE MULTIPURPOSE EVACUATION CENTER, OTHER STRUCTURES AND INSTALLATIONS, MACHINERIES AND OTHER EQUIPMENT

RESOLVED FURTHER, that this gratuitous conveyance shall be made in accordance with relevant government accounting and auditing laws, rules, and regulations.
