ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A DEED OF USUFRUCT FOR THE GRANT OF USUFRUCTUARY RIGHTS IN FAVOR OF TECHNICAL EDUCATION SKILLS AND DEVELOPMENT AUTHORITY (TESDA) COVERING A ONE THOUSAND SQUARE METER PORTION OF THE ISABELA GOVERNMENT CENTER TO HOUSE THE TESDA ISABELA PROVINCIAL OFFICE

WHEREAS, TESDA Isabela aspires to construct a structure in the Province of Isabela, one that will house their administrative offices and training center for the purpose of streamlining the administrative functions of their office in various training programs, capacity building value formation seminars/activities for local government agencies and line agencies in the Province of Isabela;

WHEREAS, the Provincial Governor, Honorable Rodolfo T. Albano III, sent a Letter addressed to the Sangguniang Panlalawigan conveying his desire to accommodate such aspiration of TESDA Isabela by providing them with usufructuary rights over a portion of the Isabela Government Center, located in Brgy. Alibagu, City of Ilagan, Isabela, measuring One Thousand Square Meters (1,000 sq. m.);

WHEREAS, this Honorable Body considers this liberal endeavor of the Honorable Provincial Governor to be advantageous to the Isabeleño populace and consistent with the policy of the Provincial Government of Isabela to make quality education more accessible to its people;

WHEREAS, Section 465, par. VI of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREFORE, premises considered, upon motion of Hon. Abegail V. Sable, duly approved and seconded in a session duly assembled it was –
