WHEREAS, the country is experiencing an unprecedented public health crisis due to the spread and pervasiveness of COVID-19;

WHEREAS, various countries and private entities are engaged in the development of safe and effective vaccines against COVID-19, among which is the Russian Federation, through its Gamaleya Research Institute of Epidemiology and Microbiology, that developed a vaccine candidate which it named as Sputnik V;

WHEREAS, the Russian Federation duly authorized the Philippine Archipelago International Trading Corporation to communicate and coordinate with Philippine government authorities for the acquisition of the Sputnik V Vaccine;

WHEREAS, the Provincial Government of Isabela, in fulfillment of its mandate to safeguard the health and safety of its people, is eager to conduct mass COVID-19 vaccinations for the immediate resolution of the ongoing pandemic;

WHEREAS, the Provincial Government of Isabela is desirous to obtain doses of Sputnik V for its local mass COVID-19 vaccination campaign;

WHEREAS, the National Task Force Against COVID-19 (NTF-COVID19) is the lead agency in the implementation of the policies, rules, and regulations issued by the National Government to address and resolve the COVID-19 pandemic;

WHEREAS, the acquisition of COVID-19 vaccines and the conduct of COVID-19 vaccinations require the approval of the NTF-COVID19 and the Department of Health;

WHEREAS, to facilitate the process of acquiring Sputnik V doses, the Provincial Government of Isabela aspires to enter into an Agreement with the NTF-COVID19, the Department of Health, and Philippine Archipelago International Trading Corporation;

WHEREAS, presented for consideration of this Honorable Body is the proposed Agreement between the Provincial Government of Isabela, NTF-COVID19, the Department of Health, and Philippine Archipelago International Trading Corporation for the acquisition of Sputnik V doses;

WHEREAS, this Honorable Body finds the Agreement to be just, reasonable, lawful, and in line with the campaign of the Provincial Government of Isabela and the National Government to resolve the COVID-19 pandemic;

WHEREAS, Section 465, par. VI of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREFORE, premises considered, upon motion of Honorable Faustino U. Dy IV, duly approved and seconded in a session duly assembled, it was –
