A RESOLUTION ENCOURAGING LOCAL GOVERNMENT UNITS (LGUs) IN THE PROVINCE OF ISABELA TO REQUIRE RT-PCR TEST FOR ALL TRAVELERS COMING FROM OUTSIDE THE PROVINCE, INCLUDING LOCALLY STRANDED INDIVIDUALS (LSIs) AND RETURNING OVERSEAS FILIPINOS (ROFs) BEFORE ALLOWING ENTRY IN THEIR RESPECTIVE TERRITORY

WHEREAS, the General Welfare Clause of the Local Government Code 1991 authorizes every Local Government Unit to enact such measures that will enhance the public health, safety, convenience, maintain peace and order and promote the general prosperity of its inhabitants;

WHEREAS, as of April 6,2021, the surge of COVID-19 cases in the Philippines is continuing with a total of 812,750 positive cases and with already 13,817 recorded deaths;

WHEREAS, on April 7, 2021, the Province of Isabela is the overall leader on a provincial level with 601 new cases;

WHEREAS, the entry of all travelers coming from outside the province, including Locally Stranded Individuals (LSIs) and Returning Overseas Filipinos (ROFs), without ensuring that they are free from coronavirus infection has been associated with the new cluster of the disease;

WHEREAS, the Inter-Agency Task Force on Emerging Infectious Diseases (IATF-EID) enjoins all LGUs for the continued implementation of proactive measures and restrictions to slow down the surge of COVID-19 cases, stop further spread of variants and to protect and save more lives;

WHEREAS, the implementation of strict travel protocols by requiring, closely monitoring, and continually evaluating responsive health assessment procedures to effectively mitigate the risk and avoid the further spread of COVID-19 to the province must be mandatory to ensure that all travelers coming from outside the province are cleared from any symptoms and have been tested negative for COVID-19 using RT-PCR Test;

WHEREAS, this Honorable Body vows that it will tirelessly assert its mandate to uphold, protect, and promote the health, safety, and general welfare of Isabeleños especially during this time of pandemic. Accordingly, it undertakes to enact all possible measures to protect the lives of our constituents;

WHEREFORE, premises considered, upon motion of Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a Special Session duly assembled, it was
