WHEREAS, His Excellency, President Rodrigo R. Duterte, signed into law Republic Act No. (RA) 11535 which made the appointment of Cooperative Development Officers mandatory at the municipal, city, and provincial government levels;

WHEREAS, this Honorable Body considers the approval of RA 11535 as a welcome development towards providing the people and communities with genuine socio-economic empowerment and real opportunities for self-reliance;

WHEREAS, given the importance of cooperatives, this Honorable Body determines that it is imperative that all City and Municipal Government Units in Isabela to appoint a Cooperative Development Officer in order to ensure the attainment of our collective goal of achieving greater and more comprehensive economic progress and prosperity in the Province;

WHEREFORE, premises considered, upon motion of Honorable Faustino U. Dy IV, duly approved and seconded in a session duly assembled, it was –
