WHEREAS, through her efforts and hardwork as head of the PCDO, the Provincial Government of Isabela received numerous national and local recognitions in the field of Cooperative Development. Among the significant awards received by the PGI are: First Placer, Best Performing LGU Cooperative Development Office in Region II Cooperative Development Authority Gawad Parangal, and Second Placer, Best Performing LGU Cooperative Development Office in the Philippines Cooperative Development Authority Gawad Parangal in 2015; and CDA Gawad Parangal, Best Performing LGU Cooperative Development Office in the Philippines in 2017;

WHEREAS, her enthusiasm at work has empowered Isabeleños and provided them with confidence to create their own sources of livelihood which resulted in the enhancement of Isabela's employment rates and the further reduction of Province's poverty rates from 31.1% in 2009 to a mere 16.7% in 2018. With this significant reduction in poverty rates, Isabela began to experience substantial economic growth and progress with Isabeleños gaining a 26% increase in their purchasing power, all because of her humble contributions in cooperative development;

WHEREAS, as she now departs from us, the PGI takes pride and gratitude for her service and contributions as Provincial Cooperative, Livelihood, and Enterprise Development Officer. She will always be remembered as hardworking, energetic and dedicated public servant who touched the lives of many Isabeleños;

WHEREAS, with this expression of sympathy and heartfelt condolences, this August Body finds it fitting and proper to pay its respect to the person who had given 30 years of her life to the Province and joins the bereaved family in beseeching our Creator in His wisdom and compassion to grant her soul eternal rest and peace in His glorious kingdom;
