A RESOLUTION DECLARING ORDINANCE NO. 293-2021 OF THE MUNICIPALITY OF **AURORA, ISABELA, AS VALID**

WHEREAS, Section 56 of R. A. No. 7160 otherwise known as the Local Government Code of the Philippines, empowers the Sangguniang Panlalawigan to review City and/or Municipal Ordinances, examine the documents, transmit the same to the concerned Committee/Council, and decide on its validity or invalidity;

WHEREAS, last April 26, 2021, the Municipality of Aurora, Province of Isabela, thru its Secretary to the Sanggunian, Hon. Castor P. Cauilan Jr., submitted for review to this Honorable Body, Ordinance No. 293-2021, which expressly grants authority to its Municipal Mayor, Hon. Joseph Christian G. Uy, who intends to enter into a Term Loan Agreement with the Development Bank of the Philippines (DBP) amounting to TWO HUNDRED MILLION PESOS (P200,000,000.00);

WHEREAS, the aforesaid loan will be used to finance the following projects: (1) Construction of 3-Storey Multi-Purpose Building; (2) Land Development of 2.2 Hectares Lot Site of the Multi-Purpose Building; (3) Purchase of 2 Hectares Lot with Lot Development Intended for Site of ISU-Cauayan Campus-Aurora Extension; and (4) Purchase of 1 Hectare Lot with Land Development and Construction of Building for Bagsakan Center;

WHEREAS, Ordinance No. 293-2021 was included in the May 6, 2021 Agenda of this Honorable Body which in turn appropriately referred the same to the Committee on Municipal Appropriations for further action;

WHEREAS, the Committee on Municipal Appropriations endorsed the aforesaid Ordinance to the Provincial Budget Office for its evaluation and assessment, as per procedure of the review of local appropriations;

WHEREAS, the Provincial Budget Office concluded its evaluation and assessment of said Ordinance and therefore submitted an Indorsement last May 24, 2021 stating that it has no adverse findings and will not interpose any objection for its passage;

WHEREAS, the Honorable Body adopts the Recommendation of the Provincial Budget Office and upholds its findings and non-objection to the Ordinance;

WHEREAS, premises considered, upon motion of Honorable Delfinito Emmanuel L. Albano, duly approved and seconded in a session duly assembled, it was —

RESOLVED, AS IT IS HEREBY RESOLVED, TO PASS A RESOLUTION DECLARING ORDINANCE NO. 293-2021 OF THE MUNICIPALITY OF AURORA, ISABELA, AS VALID.
