WHEREAS, Rule 29(A) of the Implementing Rules and Regulations of the EPIRA provides that Generation Facilities and/or Energy Resource Development Facilities, are required to provide Financial Benefits under ER 1-94 equivalent to one centavo per kilowatt-hour (P0.01/kWh) of its total electricity sales to the Host region, province, city or municipality, and barangay;

WHEREAS, Energy Regulations No. (ER) 1-94 is a policy under the Department of Energy Act of 1992 and Electric Power Industry Reform Act of 2001 (EPIRA) which stipulates that host communities will get a share of one centavo for every kilowatt-hour (P0.01/kWh) generated by power plants operating in its area;

WHEREAS, Cagayan Biomass Energy Corporation (CBEC) is a duly-registered with the Securities and Exchange Commission, established to generate, sell, supply electricity through the exploration, development, and utilization of alternative and/or renewable sources of energy and technologies;

WHEREAS, the CBEC is a GenCo operating in the Province of Isabela and is principally located at Gamu-Roxas Road, Barangay Raniag, Burgos, Isabela. Accordingly, it is mandated to provide ER 1-94 benefits to the Province of Isabela;

WHEREAS, to facilitate the Province's receipt of its ER 1-94 benefits, the Provincial Government of Isabela must open two Accounts at Land Bank of the Philippines, Ilagan City Branch, as follows:

- 1. PROVINCIAL GOVERNMENT OF ISABELA-CBEC-DLF (ER 1-94); and
- 2. PROVINCIAL GOVERNMENT OF ISABELA-CBEC-RWMHEEF (ER1-94).

WHEREAS, Section 465, par. VI of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions upon authority of the Sangguniang Panlalawigan;

WHEREAS, granting the Provincial Governor with the necessary authority to open such accounts on behalf of the Provincial Government of Isabela will result in the enhancement of the capacity and capability of the local government to extend much-needed programs, initiatives, and services to its people hence advantageous and beneficial to the Province;

WHEREFORE, upon motion of HON. FAUSTINO U. DY IV, duly seconded and approved in a session duly assembled, it was —

RESOLVED AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HON. RODOLFO T.
