ALBANO III, TO ACCUMULATE ALL CASH DONATIONS FOR TYPHOON ULYSSES AND UTILIZE THE SAME FOR REHABILITATION PURPOSES AND PROCUREMENT OF AUXILIARY EQUIPMENT SUCH AS BUT NOT LIMITED TO LANDING PORT TO FACILITATE TRANSPORT AND PROVISION OF GOODS FOR DELIVERY TO **VICTIMS OF TYPHOONS AND OTHER CALAMITIES**

WHEREAS, the Province of Isabela experienced widespread devastation due to the entry of Typhoon Ulysses;

WHEREAS, the said typhoon brought heavy rainfall that resulted in rapid and extensive flooding in countless houses, crops, and farmlands in the province, various roads and bridges became impassable, numerous establishments closed operations and several homes were destroyed leaving numerous communities homeless and vulnerable amidst the ongoing COVID-19 pandemic;

WHEREAS, seeing the impact of Typhoon Ulysses in hard-hit areas, various groups and individuals extended their help by offering cash and in kind donations to the Province of Isabela;

WHEREAS, due to massive donation and relief drives by various groups and individuals on the affected communities, part of the monetarial donations for typhoon Ulysses in the province remain unutilized;

WHEREAS, the Provincial Government of Isabela desires to accumulate all cash donations for Typhoon Ulysses and utilize the same for rehabilitation purposes and procurement of auxiliary equipment such as but not limited to landing Port to facilitate transport and provision of goods for delivery to victims of typhoons and other calamities;

WHEREAS, this Honorable Body considers the importance of these initiatives in the recovery and rebuilding efforts in the affected areas as well as improvement of the delivery of services and flow of goods in the coastal municipalities of the province who are first to suffer the wrath of typhoons;

WHEREAS, Section 465, par. VI of the Local Government Code of 1991 empowers the Provincial Governor to represent the Province in all its business transactions and sign in its behalf all contracts and such other documents upon authority of Sangguniang Panlalawigan;

WHEREFORE, premises considered, upon motion of Hon. Alfredo V. Alili, duly approved and seconded in a session duly assembled it was –

RESOLVED, AS IT IS HEREBY RESOLVES, TO PASS A RESOLUTION GRANTING AUTHORITY TO PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO ACCUMULATE ALL CASH DONATIONS FOR TYPHOON ULYSSES AND UTILIZE THE SAME FOR REHABILITATION PURPOSES AND PROCUREMENT OF AUXILIARY EQUIPMENT SUCH AS BUT NOT LIMITED TO LANDING PORT TO FACILITATE TRANSPORT AND PROVISION OF GOODS FOR DELIVERY TO VICTIMS OF TYPHOONS AND OTHER CALAMITIES

RESOLVED FURTHER, that other cash donations with an existing condition or for a special purpose shall not be accumulated and be included in the utilization for rehabilitation purposes.

RESOLVED FURTHERMORE, that the utilization of the accumulated donations shall be subject to government accounting and auditing laws, rules and regulations.

RESOLVED FINALLY, to furnish: the Provincial Governor, Hon. Rodolfo T. Albano III; and the Provincial Information Officer, Atty. Elizabeth C. Binag, for its dissemination in all appropriate platforms.
