A city or municipality may, through an ordinance passed by the Sanggunian after conducting public hearings for the purpose, authorize the reclassification of agricultural lands and provide for the manner of their utilization or disposition in the following cases: (1) when the land ceases to be economically feasible and sound for agricultural purposes as determined by the Department of Agriculture or (2) where the land shall have substantially greater economic value for residential, commercial, or industrial purposes, as determined by the Sanggunian concerned: Provided, That such reclassification shall be limited to the following percentage of the total agricultural land area at the time of the passage of the ordinance;

WHEREAS, Section 56 of the LGC establishes the authority of the Sangguniang Panlalawigan to review city or municipal ordinances for the purpose of determining if such is beyond the power conferred upon the sangguniang panlungsod or sangguniang bayan;

WHEREAS, the Committee on Housing, Subdv. & Land Use Classification, after a thorough review, finds that Ordinance No. 18-2020 of the Municipality of Tumauini is in consonance to the mandate of the Sangguniang Bayan pursuant to Section 20 of the Local Government Code. Thus, the said Ordinance is within the scope of the powers conferred by law to their Sangguniang Bayan;

WHEREAS, the Committee recommended to the August Body to uphold the validity of Ordinance No. 18-2020 of the Municipality of Tumauini;

NOW THEREFORE, above premises considered, upon motion of HON. ED CHRISTIAN S. GO, duly approved and seconded in a session duly assembled, it was:
