WHEREAS, recognizing this shortage, the Provincial Government of Isabela has requested SN Aboitiz Power Magat, Inc. to provide an ambulance to augment the capacity of local medical facilities to accommodate the transportation needs of COVID-19 patients;

WHEREAS, SN Aboitiz Power Magat, Inc. has accepted such request and has agreed to donate one (1) unit ambulance to the Provincial Government of Isabela;

WHEREAS, the receipt of such ambulance requires the execution of a Memorandum of Agreement between the Provincial Government of Isabela and SN Aboitiz Power Magat, Inc.;

WHEREAS, Section 465, par. VI of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREFORE, premises considered, upon motion of Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –
