A RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 86. SERIES OF 2022 OF THE SANGGUNIANG BAYAN OF CABAGAN, ISABELA AS INTRA VIRES

WHEREAS, pursuant to Article 468(a)(i) of the Local Government Code, the Sangguniang Panlalawigan has the authority to "review all ordinances approved by the sangguniang of component cities and municipalities" and to "determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor"

WHEREAS, presented before this Honorable Body is Municipal Ordinance No. 86, series of 2022 enacted by the Sangguniang Bayan of Cabagan, Isabela titled "An Ordinance Reclassifying Land Lots 1890, 2782, 2781, and 1888 Located at Brgy. Ugad, Cabagan, Isabela from Commercial Use to Memorial Park";

WHEREAS, as provided in the Ordinance, the Sangguniang Bayan of Cabagan, Isabela changed the classification of the four aforementioned lots from commercial zone to memorial park zone;

WHEREAS, the Municipal Local Government Unit of Cabagan, Isabela, pursuant to a Zoning Ordinance duly enacted by their Sangguniang Bayan, recognizes "Memorial Park Zone" as a valid land use classification within their jurisdiction;

WHEREAS, this Honorable Body recognizes that local government units are more abreast with regard to the needs of their citizens and the conditions within their jurisdiction and thus have the necessary competence in formulating the appropriate strategies and implementing the essential measures for the advancement of their people and territory;

WHEREAS, after careful review, subject to pertinent regulations and issuances of the Housing and Land Use Regulatory Board and other relevant laws and rules, this Honorable Body finds that the reclassification of the four aforementioned lots from commercial zone to memorial zone made pursuant to Ordinance No. 86, series of 2022 of the Sangguniang Bayan of Cabagan, Isabela to be a valid exercise of their legislative power and is within the authority of the Municipal Local Government Unit of Cabagan, Isabela as prescribed by law;

WHEREFORE, upon motion of Honorable Ed Christian S. Go, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 86, SERIES OF 2022 OF THE SANGGUNIANG BAYAN OF CABAGAN, ISABELA AS INTRA VIRES
