WHEREAS, Republic Act No. 11223, otherwise known as the "Universal Health Care Act of 2019", which provides that the DOH shall deploy health workforce under the National Health Workforce System to augment human resource needs in public health systems;

WHEREAS, the PGI is in dire need of a Medical Officer (MO) IV who will provide specialty health care to augment the medical human resource requirement in the Province;

WHEREAS, to ensure the availability of skilled health professionals who can deliver quality health care services in prioritizing poor and undeserved areas, the DOH shall deploy physicians who recently finished the residency training program in DOH Teaching and Training Hospital as human resource complement in government hospitals in priority underserved areas;

WHEREAS, pursuant to the mandate set forth in its Post-Residency Deployment Service Program, the DOH aspires to deploy a physician in Cauayan District Hospital, in the person of Dr. Sharlene Faye G. Ty of East Avenue Medical Center, to augment the medical human resource requirement in the Province;

WHEREAS, the implementation of the Post-Residency Return Service Program and the deployment of physicians to hospitals operated by the Provincial Government of Isabela necessitates the execution of a Memorandum of Agreement;

WHEREAS, Section 465, par. VI of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign contracts and such other documents relative to the execution of his functions, upon the authority vested upon him by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

WHEREAS, premises considered, upon motion of Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was -
