A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 2021-01 (SUPPLEMENTAL BUDGET NO. 01 S. 2021) IN THE AMOUNT OF ONE MILLION FIVE HUNDRED TWO THOUSAND PESOS (P1,502,000.00) OF THE MUNICIPALITY OF SAN MATEO, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO CONDITIONS

NOW THEREFORE, on motion of **SP Member DELFINITO EMMANUEL L. ALBANO** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2021-01 of the Municipality of San Mateo, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160 and subject further to the following conditions:

- 1. The creation of the position of Sectoral Representative for Agricultural Worker may be allowed subject to the following conditions:
 - It is the priority needs as identified by the LCE, the Sanggunian and/or LDCs concerned consistent with Section 17 of RA No. 7160:
 - All mandatory positions stipulated under RA No. 7160 have been created and provided;
 - The SSL has been fully implemented;
 - The general limitations on PS expenditures are not exceeded; and
 - The classification of the position is consistent with the standards and implementing rules and regulations of RA No. 6758.
- 2. The Appropriation for LDRRMF in the amount of Seventy Five Thousand One Hundred Thirty Pesos & 08/100 (P75,130.08) shall adhere to the provisions of Republic Act 10121, DILG Memorandum Circular No. 2012-73 dated April 17, 2012 and NDRRMC-DBM-DILG JMC No. 2013-1 dated March 25, 2013. Provided further, that the LDRRMF Supplemental Annual Investment Program shall be reviewed by the Office of Civil Defense (OCD) pursuant to RA 10121 and its implementing Rules and Regulations supplemented by Local Budget Memorandum No. 80 dated May 18, 2020, copy furnish the Office of the Sangguniang Panlalawigan of the reviewed LDRRMF;
- 3. The Municipality of San Mateo, Isabela shall submit certification of availability of funds by the Municipal Treasurer.
- 4. The appropriation for the following accounts should be properly classified to specific Object of Expenditures and Account Code in accordance with COA Circular No. 2015-009 dated December 1, 2015, on Prescribing the Revised Chart of Accounts for LGUs:
