**WHEREAS**, the Philippines experienced an unprecedented health, social, and economic crisis due to the spread of the COVID-19;

**WHEREAS**, His Excellency, President Rodrigo Roa Duterte, placed the country under a State of Public Health Emergency and called for a *whole-of-nation approach* to effectively address the challenges caused by the COVID-19 pandemic;

**WHEREAS**, recognizing that solidarity and cooperation among local government units and improving the public's access to COVID-19 vaccines are vital in addressing the challenges caused by COVID-19, the Local Government of Iloilo City has made available to *donee-beneficiaries* its excess COVID-19 vaccines;

**WHEREAS**, the Local Government of Iloilo City has selected the Provincial Government of Isabela as one of its *donee-beneficiaries* and is desirous to donate to the same 2,000 vials of AstraZeneca vaccines;

**WHEREAS**, presented for the consideration of this Honorable Body is a Letter from the Provincial Governor, Honorable Rodolfo T. Albano III, requesting that he be granted with authority in the signing of a Deed of Acceptance on behalf of the Provincial Government of Isabela to effectuate the receipt of the COVID-19 vaccine vials donated by the Local Government of Iloilo City;

**WHEREAS**, Section 465, par. (b)(1)(vi) of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

**WHEREAS**, this Honorable Body acknowledges the fact that granting the Provincial Governor with the sought authority will boost the Province's vaccine supply and strengthen its vaccination programs hence favorable to the Provincial Government of Isabela;

**WHEREAS**, this Honorable Body extends its appreciation and gratitude to Iloilo City Mayor, Honorable Jerry P. Treñas, and the entire Local Government of Iloilo City for the generosity that they displayed towards the Province of Isabela;

**WHEREFORE**, upon motion of Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –
