A RESOLUTION UPHOLDING THE VALIDITY OF GENERAL ORDINANCE NO. 302, SERIES OF 2022 OF THE CITY OF ILAGAN, ISABELA ENTITLED, "AN ORDINANCE APPROVING THE RECLASSIFICATION OF NINE THOUSAND FIVE HUNDRED (9,500) SQUARE METERS PORTION OF THE AGRICULTURAL LAND REGISTERED IN THE NAME OF HONORACIO B. SOCAN MARRIED TO REMEDIOS PADILLA, COVERED UNDER CERTIFICATE OF TITLE NO. WHEREAS, Section 20 (a) of R. A. 7160 or the Local Government Code of 1991 grants a municipality the power to authorize the reclassification of agricultural lands into a residential, commercial or industrial purposes and was more specifically stated as follows:

"A city or municipality may, through an ordinance passed by the Sanggunian after conducting public hearings for the purpose, authorize the reclassification of agricultural lands and provide for the manner of their utilization or disposition in the following cases: (1) when the land ceases to be economically feasible and sound for agricultural purposes as determined by the Department of Agriculture

or (2) where the land shall have substantially greater economic value for residential, commercial, or industrial purposes, as determined by the Sanggunian concerned: Provided, That such reclassification shall be limited to the following percentage of the total agricultural land area at the time of the passage of the ordinance";

WHEREAS, General Ordinance No. 302 was enacted by the Sangguniang Panlungsod of Ilagan, Isabela, reclassifying agricultural lands under the portion covered by Transfer Certificate of Title No. T-173281 located at Barangay Calamagui 1st, City of Ilagan, Isabela, with a total lot area of 9,500 square meters, more or less, from agricultural to industrial purpose;

WHEREAS, Section 3 of Memorandum Circular No. 54, Series of 1993 of the Office of the President provides that: "All ordinances authorizing the reclassification of agricultural lands shall be subject to the review and approval by the province in the case of component city or municipality";

WHEREAS, having been authorized to review ordinances reclassifying agricultural lands under the abovesaid Memorandum Circular, the Committee on Housing, Subdivision and Land Use Classification conducted a thorough review of General Ordinance No. 302 and finds the same to be in consonance to the mandate of the Sangguniang Panlungsod pursuant to Section 20 of R.A. No. 7160. Thus, said Ordinance is within the powers conferred by law to their Sangguniang Panlungsod;

WHEREAS, the Committee recommended that the validity of General Ordinance No. 302 of the City of Ilagan, Isabela be upheld to which this Honorable Body concurred;

**NOW THEREFORE**, upon motion of **HON**. **ED CHRISTIAN S. GO**, duly approved and seconded in a session duly assembled, it was –
