WHEREAS, the Provincial Government of Isabela is the administrator of a certain parcel of land located at Brgy. Osmeña, City of Ilagan, reserved for Provincial Government Center, Boy Scouts and Girl Scouts Camp, and School Site purposes by virtue of Presidential Proclamation No. 234 dated January 16, 1951;

WHEREAS, the National Bureau of Investigation – Isabela District Office has previously established its Provincial Office within the abovementioned parcel of land, more particularly in Lot No. 3 of SGS-2-02-001062, located at Brgy. Osmeña, City of Ilagan, Isabela containing an area of Nine Thousand Two Hundred Twenty-Five (9225) Square Meters since July 6, 1979;

WHEREAS, the Provincial Government of Isabela recognizes the importance of having a better working environment in order for the National Bureau of Investigation – Isabela District Office to provide quality investigative and forensic services to the people through advanced methods and equipment in the pursuit truth and justice;

WHEREAS, the Provincial Government of Isabela desires to donate the subject parcel of land to the National Bureau of Investigation – Isabela District Office;

WHEREAS, Section 465, (b) (1) (vi) of R.A. No. 7160 empowers the Provincial Governor to represent the Province in all its business transactions and sign in its behalf all contracts and such other documents upon issuance of authority by the Sangguniang Panlalawigan;

WHEREAS, considering the reasonableness and absence of any legal impediment to the subject donation, this Honorable Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Deed of Donation on behalf of the Provincial Government of Isabela;

WHEREFORE, premises considered, upon motion of Hon. Alfredo V. Alili, duly approved and seconded in a session duly assembled it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION GRANTING AUTHORITY TO PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, ON BEHALF OF PROVINCIAL GOVERNMENT OF ISABELA, TO ENTER INTO A DEED OF DONATION WITH THE NATIONAL BUREAU OF INVESTIGATION — ISABELA DISTRICT OFFICE.
