WHEREAS, consistent with the Philippine Development Plan, the Philippine Health Agenda focuses on the attainment of health related Sustainable Development Goals (SDGs) financial risk protection, better health outcomes, and the responsiveness of the health system;

WHEREAS, to ensure the realization of the overall health related goals, there is a need to address the issues on rising cost of health care in the country, the inability to gain access to quality essential health-care services and to safe, effective, quality and affordable medicines for all;

WHEREAS, cognizant of such concern, the Office of the President will allocate Fifty Million Pesos (P50,000,000.00), for prescription medicines, medical supplies/devices and diagnostic tests and other hospital care medical services, and support to indigent, vulnerable and disadvantaged patients to be sourced from the Office of the President's Socio-Civic Projects Fund (SCPF);

WHEREAS, the Provincial Government of Isabela (PGI) aspires to promote the well being of its constituents through the provision of free medical care to indigent, vulnerable and disadvantaged patients;

WHEREAS, PGI's availment of the said financial assistance and the implementation thereof requires the execution of a Memorandum of Agreement between the PGI and the Office of the President;

WHEREAS, Section 465 (b) (1) (vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign contracts and such other documents relative to the execution of his functions, upon the authority vested upon him by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

WHEREAS, premises considered, upon motion of Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was -
