**RESOLVED,** to declare Appropriation Ordinance No. 2021-312 (2022 Annual Budget) of the Municipality of Angadanan, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160 and subject further to the following conditions:

That the positions of Midwife with incumbents as reflected under the duly approved personnel schedule **shall be downgraded to Midwife I once vacated** pursuant to Item D.1 of the Supplemental Guidelines on the Standard Staffing Pattern and Annex — Tally of Positions of the Revised Organizational Structure and Staffing Standards for Government Hospitals under DOH-DBM Joint Circular No. 2013-1 dated September 23, 2013, to wit:

- 4. Reiterating that the account Other Professional Services shall be properly classified to Account Code 5-02-11-990 and its utilization in the amount of Five Million Ninety Eight Thousand Pesos (P5,098,000.00) shall be in accordance with COA Circular No. 2015-009 dated December 1, 2015, on the Description of Accounts under the Revised Chart of Accounts for Local Government Units;
- 5. The Utilization of the Appropriation for Other General Services in the amount of Sixteen Million Six Hundred Seventy Eight Thousand One Hundred Twenty Five Pesos (P16,678,125.00) shall be in accordance with COA Circular No. 2015-009 dated December 1, 2015, on the Description of Accounts under the Revised Chart of Accounts for Local Government Units;
- 6. This is to reiterate our review on your Annual Budget FY 2021 that the appropriation for **Donations** under the Municipal Social Welfare and Development Office in the amount of Five Million Two Hundred Sixty Nine Thousand Five Hundred Thirty Four Pesos & 08/100 (P5,269,534.08) shall be classified according to its specific Programs, Projects & Activities (PPAs);
- 7. The utilization of 5% LDRRMF shall be in accordance with the approved Local Disaster Risk Reduction and Management Plan pursuant to RA 10121 and its implementing Rules and Regulations, as supplemented by NDRRMC-DBM-DILG JMC No. 2013-1 dated March 25, 2013. Provided further, that the LDRRMF Plan shall be reviewed by the Office of Civil Defense (OCD) pursuant to RA 10121 and its implementing Rules and Regulations as supplemented by Local Budget Memorandum No. 82 dated June 14, 2021 copy furnish the Office of the Sangguniang Panlalawigan of the reviewed LDRRMF;
- 8. The utilization of the appropriation for the 20% Development Fund shall be in accordance with DILG-NEDA-DBM and DOF JMC No. 1 Series of 2007 and shall strictly cover only the development projects prescribed and authorized under DBM-DOF-DILG Joint Memorandum Circular No. 1 dated November 4, 2020 and DILG-DBM Joint Memorandum Circular No. 01 dated March 27, 2020, the Additional Guidelines on the Utilization of the Twenty Percent (20%) of the Annual Internal Revenue Allotment for Development Projects in View of the CORONAVIRUS INFECTIOUS DISEASE (COVID-19) Situation;

9. All procurement activities shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations. Further, the acquisition of Motor Vehicles (Motorcycle, Water Truck & 4WD Tractor) shall be subject to the provisions of Budget Circular No. 2019-3 dated May 16, 2019 and Administrative Order No. 14 dated December 10, 2019;

**RESOLVED FURTHER**, to require the Municipality of Angadanan, Isabela to comply with the herein review findings and/or conditions and notify this body of actions taken thereon.

**RESOLVED FURTHERMORE**, to furnish the Municipality of Angadanan, Isabela that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

**RESOLVED FINALLY**, to furnish a copy of this Resolution to the Sangguniang Bayan of the Municipality of Angadanan, Isabela through the **Honorable DIOSDADO S. SIQUIAN**, Municipal Vice Mayor, and **Honorable JOELLE MATHEA S. PANGANIBAN**, Municipal Mayor.
