WHEREAS, Appropriation Ordinance No. 2021-03, an Ordinance authorizing Supplemental Budget No. 02 Series of 2021 of the Municipality of San Mateo, Isabela, involving the amount of SIXTEEN MILLION PESOS (P16,000,000.00) from the proceeds of Ioan and Donations from ATI for winning the Rice Achiever's Award for the Construction of One (1) unit Water Pump and Purchase of Lot to be used as Goat Breeding Farm & Other Livestock Projects of the Municipal Government of San Mateo, Isabela, was submitted to this Sanggunian for review pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 2021-03 (SUPPLEMENTAL BUDGET NO. 02 S. 2021) IN THE AMOUNT OF SIXTEEN MILLION PESOS (P16,000,000.00) OF THE MUNICIPALITY OF SAN MATEO, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO CONDITIONS

NOW THEREFORE, on motion of **SP Member DELFINITO EMMANUEL L. ALBANO** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2021-03 of the Municipality of San Mateo, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160 and subject further to the following conditions:

1. That the Fifteen Million Pesos (P15,000,000.00) loan of the Municipality of San Mateo, Isabela, must be governed by Sec. 324 (b) of RA 7160, which states:

"That the amount of Appropriations for debt servicing shall not exceed twenty percent (20%) of the regular income of the LGU concerned."

2. All procurement activities shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its 2016 Revised Implementing Rules and Regulations;

RESOLVED FURTHER, to require the Municipality of San Mateo, Isabela to comply with the herein review findings and/or conditions and notify this body of actions taken thereon.

RESOLVED FURTHERMORE, to inform the Municipality of San Mateo, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the Sangguniang Bayan of the Municipality of San Mateo, Isabela through the **Honorable CRISPINA R. AGCAOILI**, Municipal Vice Mayor, and **Honorable GREGORIO A. PUA**, Municipal Mayor.
