The Provincial Government of Isabela holds the Bambanti Festival every January of each year to express its appreciation and gratitude to its local farmers for their contributions to the progress being enjoyed by the province.

For several years, the Department of Agriculture awarded the Province of Isabela the Rice Achievers for Outstanding Province distinction in recognition of its excellent rice production. The said recognition had corresponding grants of a monetary award by the Department of Agriculture to the Provincial Government of Isabela which was downloaded into the latter's trust fund "Cash Award for the various Agri-Pinoy Most Outstanding Province (Corn & Rice) from 2012-2019 Rice Achievers Awards for Outstanding Province". And, as per records as of the date of this ordinance, there are unexpended balances under such trust fund amounting to Php6,348,545.68.

The Office of the Provincial Governor sent a letter addressed to this August Body requesting that the said unexpended balances be reprogrammed to augment funds for the observance of the 2023 Bambanti Festival.

Considering that the purpose for the grant of the monetary award in attaining the Rice Achievers for Outstanding Province Trust Fund is in line with the objectives of the Bambanti Festival, this August Body finds that the request of the Office of the Provincial Governor to be just and proper hence the passage of this Ordinance is earnestly sought.
