The DOH – Cagayan Valley Center for Health Development (DOH – CVCHD) was granted funds, pursuant to Republic Act No. 11936 or the General Appropriations Act of FY 2023, to implement the Health Facilities Enhancement Program (HCEP) in Region 02 and has selected the Province of Isabela as one of the program's implementation sites.

As part of the commitment of DOH- CVCHD to improve healthcare and medical facilities in the Province of Isabela, it granted the Provincial Government of Isabela the amount of Php15,000,000.00 for the "Completion/Upgrading/Repair of Gov. Faustino N. Dy, Sr. Memorial Hospital, Calamagui 2nd, City of Ilagan, Isabela".

The receipt of the grant was authorized by this August Body through Sangguniang Panlalawigan Resolution No. 2023-13-18.

The Office of the Provincial Governor sent a letter to this August Body requesting that the granted amount be reprogrammed for the "Construction of 4 Storey Medical Arts Building. (Phase IV), Calamagui 2nd, City of Ilagan, Isabela."

Considering that the requested reprogramming of funds is consistent with the objectives of the HCEP and that it will result in the construction of a 4-storey medical arts building, this August Body finds the request of the Provincial Governor to be just, lawful, and appropriate.

In view of the foregoing, the immediate passage of this ordinance is earnestly sought.
