promoting sustainable and resilient economies. Furthermore, their democratic and participatory nature fosters a sense of ownership and shared responsibility, leading to more resilient, equitable, and people-centered economies. Recognizing this, the Provincial Government of Isabela (PGI) actively fosters the creation and growth of cooperatives in Isabela to raise productivity and advance the economic resilience of its communities.

Towards this end, the PGI appropriates significant resources to enable cooperatives to develop into viable and responsive enterprises through the extension of technical guidance and financial assistance, among others. One of the pro-cooperative programs that the PGI implements is the Isabela Recovery Initiatives to Support Enterprises (I-RISE) Livelihood Program. Under this program, the PGI offers qualified cooperatives access to financing through the provision of livelihood assistance and loans with zero-interest rates which can be utilized as start-up funds or as means to improve or expand their operations.

For Fiscal Year 2023, the PGI appropriated Php100,000,000.00 for the two aspects of the I-RISE Program: Php60,000,000.00 to the interest-free lending program, and Php40,000,000.00 for the extension of livelihood assistance for micro and small entrepreneurs, and those from the informal sector, youth, PWDs, and other marginalized sectors.

However, records show that some of the beneficiaries of the I-RISE interest-free lending program experience difficulties in paying their loans to the PGI citing their lack of marketing capabilities which resulted in low sales rates. Recognizing this, the PGI acknowledged the need to shift the focus of the I-RISE program from providing capital assistance to bridging the producer-consumer gap.

The PGI aims to address this gap by purchasing the cooperative's products at a premium price which will be then distributed to target beneficiaries such as malnourished children, hospital patients, disaster victims, and vulnerable individuals and groups, among others. The PGI envisions that this will drive up the sales of the cooperatives which will ultimately result in the improvement of the viability and profitability of their business.

To put such measure into motion, the Office of the Provincial Governor requested this August Body for the reprogramming of funds in the amount of Php60,000,000.00 from the I-RISE Interest Lending Program to the I-RISE for Financial Assistance to Cooperatives, Associations, and Organizations.

Considering the impactful benefits that the Isabeleños will receive from this measure, its swift passage is earnestly sought.
