AN ORDINANCE REPROGRAMMING THE AMOUNT OF TWELVE MILLION SEVENTY SIX THOUSAND SIX HUNDRED NINETY EIGHT PESOS (PHP12,076,698.00) FROM THE ACCOUNT "MOTOR VEHICLES" UNDER THE CAPITAL OUTLAY OF THE PROVINCIAL VICE GOVERNOR'S OFFICE APPROPRIATED IN THE PROVINCIAL GOVERNMENT OF ISABELA (PGI) ANNUAL BUDGET FOR THE YEARS 2018, 2019, 2020, 2021, AND 2022 TO THE ACCOUNT "MOTOR VEHICLES" UNDER THE CAPITAL OUTLAY OF THE PROVINCIAL VICE GOVERNOR'S OFFICE IN THE PGI ANNUAL BUDGET FOR THE YEAR 2023

In the legislative setting, vehicles are vital in enhancing legislative efficiency, strengthening community engagement, and ensuring prompt responses to emergencies. Vehicles provide legislators with a medium that makes them more available to the public, enhances their engagement with communities, better understand the issues faced by sectors from various areas, and ensures their prompt responses to emergencies.

To ensure the attainment of the effective public service policies of the Provincial Government of Isabela, it appropriated funds in its Annual Budget for the years 2018, 2019, 2020, 2021, and 2022 for the acquisition of motor vehicles, appropriated to the Provincial Vice Governor's Office, to be utilized by the Sangguniang Panlalawigan. These appropriations were placed in the Capital Outlay of the said office under the account "Motor Vehicles".

However, with the advent of the COVID-19 pandemic and realizing the restrictions placed on travel and public gatherings during such period, the Sangguniang Panlalawigan deferred in making use of the said appropriations resulting in portions of which being unutilized. And, as per data from the Provincial Budget Office, the amount of Php12,076,298.00 remain unutilized from the said appropriations.

In line with the recent issuance of Presidential Proclamation No. 297 which effectively lifted the country's public health emergency status caused by the COVID-19 pandemic, the substantial decline in COVID-19 cases, and the normalization of the day-to-day activities in the province, the Sangguniang Panlalawigan now aspires to make use of the said unutilized funds.

To realize such an aspiration, the Provincial Budget Office recommended the reprogramming of the said unutilized funds to the account "Motor Vehicles" under the Capital Outlay of the Provincial Vice Governor's Office for Budget Year 2023, to which this August Body hereto adopts.

To advance the effective public service policies of the PGI and further improve local legislative efficiency, the immediate enactment of this ordinance is earnestly sought.

Section 4. Adherence to Relevant Laws. The reprogramming, augmentation, utilization, or disbursement of funds made pursuant to this Ordinance shall be subject to existing relevant government budgeting, accounting, and auditing laws, rules, regulations, and issuances.

Section 5. Effectivity. This Ordinance shall take effect immediately upon its approval.
