Section 3. Coverage. All personnel of the Provincial Government of Isabela who are still under its employment as of 30 November 2023, whether under regular, contractual, or casual status, and whether appointive or elective, including those employed as legislative personnel of Sangguniang Panlalawigan Members, are entitled to the herein grant of Service Recognition Incentive.

Section 4. Service Recognition Incentives. All personnel entitled to receive this incentive shall be granted an amount not exceeding TWENTY THOUSAND PESOS (Php20,000.00).

However, for those covered personnel who have rendered less than a total or an aggregate of four (4) months of satisfactory service as of 30 November 2023 shall receive a prorated SRI, as follows:

Section 5. Guidelines for the Release of Service Recognition Incentive. The PGI shall adhere to relevant government accounting and auditing laws, rules, and regulations, and pertinent issuances of the National Government pertaining to the grant of personnel benefits.

Section 6. Effectivity. This Ordinance shall take effect immediately.
