AN ORDINANCE AUTHORIZING THE REPROGRAMMING OF FUNDS UNDER THE 20% ECONOMIC DEVELOPMENT FUND OF THE PROVINCIAL GOVERNMENT OF ISABELA FOR FISCAL YEAR 2023 IN THE AMOUNT OF TWENTY MILLION PESOS (PHP20,000,000.00) FROM THE PROJECT/PROGRAM/ACTIVITY (PPA) "COMPLETION OF 50 lin.m. NANAGUAN BRIDGE, CITY OF ILAGAN, ISABELA" TO "CONTINUATION OF NANAGUAN BRIDGE, CITY OF ILAGAN, ISABELA"

SP Resolution No. 2022-22-11 approved the Annual Investment Plan of the Provincial Government of Isabela (PGI) for fiscal year 2023. This resolution empowers the Governor to augment or reprogram any item within the approved 2023 20% EDF to ensure that the resources and development plans of the PG are responsive to current development issues.

In connection with the request of the Honorable Governor, the proposed reprogramming of funds, through change of nomenclature, will ensure the successful implementation of the PGI's Nanaguan Bridge project, thus advancing our development goals and benefitting our people.

Considering that the request of the Honorable Governor is just, appropriate, and beneficial to our people, the immediate enactment of this ordinance is earnestly sought.

Section 1. Coverage. This Ordinance shall cover the items, accounts, and appropriations provided in Section 2 hereof.

Section 2. Reprogramming of Funds. The amount allocated under the 20% Economic Development Fund of the Provincial Government of Isabela for Fiscal Year 2023, as detailed below, is hereby reprogrammed as follows:

Section 3. Utilization of Funds. The utilization or disbursement of funds made pursuant to this Ordinance shall be subject to existing government budgeting, accounting, and auditing laws, rules, and regulations.

Section 4. Authority to Reprogram. To ensure that the resources and development plans of the Provincial Government of Isabela are responsive to the current development issues and that its programs, plans, and activities are effectively implemented, the Honorable Governor is hereby empowered to augment or reprogram any savings that may be derived from the herein reprogrammed fund to any item within the same appropriation.

Section 5. Effectivity. This Ordinance shall take effect immediately upon its approval.
