Accordingly, this August Body deems the aforementioned reprogramming to be in line with the purpose for which the funds were originally appropriated and that the manner of execution to be consistent with government budgeting and accounting laws, rules, and regulations hence are just, proper, and lawful.

In view thereof, the speedy enactment of this Ordinance is earnestly sought.
