A RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 16-2022 OF THE MUNICIPAL LOCAL GOVERNMENT UNIT OF QUIRINO, ISABELA AS VALID

WHEREAS, pursuant to Article 468(a)(i) of the Local Government Code, the Sangguniang Panlalawigan has the authority to "review all ordinances approved by the sangguniang of component cities and municipalities" and to "determine whether these are within the scope of the prescribed powers of the sanggunian";

WHEREAS, presented before this August Body is Municipal Ordinance No. 16-2022 of the Municipal Local Government Unit of Quirino, Isabela (MLGU Quirino) which enacted the Revised Revenue Code of the Municipality of Quirino, Province of Isabela, Series of 2022;

A RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 16-2022 OF THE MUNICIPAL LOCAL GOVERNMENT UNIT OF QUIRINO, ISABELA AS VALID

WHEREAS, Section 186 of the Local Government Code empowers local government units to levy taxes, fees, or charges on any base or subject not otherwise specifically enumerated [t]herein or taxed under the provisions of the National Tax Revenue Code, as amended, or other applicable laws: Provided, that the taxes, fees, or charges, shall not be unjust, excessive, oppressive, confiscatory or contrary to the declared national policy: Provided, further, that the ordinance levying such taxes, fees, or charges shall not be enacted without prior public hearing conducted for the purpose;

WHEREAS, this August Body sought the assistance of the Provincial Legal Office in examining the legality of the provisions of the submitted ordinance and that a sound and prudent judgment is applied in exercising its review powers over the same;

WHEREAS, after careful review, this August Body determined that Municipal Ordinance No. 10-2022 of MLGU Quirino is a valid exercise of the legislative powers of their sanggunian and within the authority of MLGU Ilagan as prescribed by law;

WHEREFORE, upon motion of Honorable Delfinito Emmanuel L. Albano, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 16-2022 OF THE MUNICIPAL LOCAL GOVERNMENT UNIT OF QUIRINO, ISABELA AS VALID

RESOLVED FINALLY, that a copy of this Resolution be furnished to MLGU Quirino officials, namely: the Honorable Municipal Mayor Edward D. Juan, and the Honorable Municipal Vice Mayor Victor Emmanuel Callangan for their information and guidance.
