WHEREAS, Republic Act No. 10152, otherwise known as the "Mandatory Infants and Children Health Immunization Act of 2011" has been enacted mandating the State to take a proactive role in the preventive health care of infants and children;

**WHEREAS,** in pursuit of such policy, the State adopts a comprehensive, mandatory, and sustainable immunization program for vaccine-preventable diseases for all infants and children;

ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT WITH THE CAGAYAN VALLEY CENTER FOR HEALTH DEVELOPMENT (CVCHD) FOR THE IMPLEMENTATION OF THE MEASLES RUBELLA ORAL VACCINE SUPPLEMENTAL IMMUNIZATION ACTIVITY (MR-OPV SIA)

WHEREAS, the mandatory basic immunization covers tuberculosis, diphtheria, tetanus, pertussis, poliomyelitis, measles, mumps, rubella or german measles, hepatitis-b, H-influenza type B, and such other types as may be determined by the Secretary of Health;

WHEREAS, the Department of Health (DOH) focuses on the management of Measles Rubella Oral Polio Vaccine Supplemental Immunization Activity (MR-OPV SIA) to prevent the occurrence of an outbreak for vaccine-preventable diseases;

WHEREAS, in pursuit of such policy, the National Government allocated a significant amount in the Sub-Allotment Advice (SAA) No. 2023-03-001476 for the implementation of the Measles Rubella Oral Polio Vaccine Supplemental Immunization Activity (MR-OPV SIA) amounting to One Hundred Twenty Thousand Pesos (P120,000.00);

WHEREAS, the National Government granted funds to the Cagayan Valley for the Health Development (CVCHD) for the implementation of the MR-OPV SIA and be beneficial to Isabeleño infants and children;

WHEREAS, submitted for the consideration of this Honorable Body is the proposed Memorandum of Agreement between the Provincial Government of Isabela and Cagayan Valley Center for Health Development which will make the MR-OPV SIA accessible to Isabeleños;

WHEREAS, Section 465(b)(1)(vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, after careful perusal, this Honorable Body determined that the proposed Memorandum of Agreement between the Provincial Government of Isabela and CVCHD is just and lawful, and will improve the Isabeleños capacity to access quality healthcare services;

WHEREFORE, upon motion of Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was -
