WHEREAS, the subject Ordinance complies with the budgetary requirements, general limitations and other pertinent provisions set forth under Republic Act No. 7160;

NOW THEREFORE, on motion of **SP Member DELFINITO EMMANUEL L. ALBANO** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2022-053 of the Municipality of Jones, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

- 1. The payment of Terminal Leave Benefit in the amount of One Million Eight Hundred Seventy Seven Thousand Seven Hundred Forty Nine Pesos & 38/100 (P1,877,749.38) shall be in accordance with DBM Budget Circular No. 2016-2 dated March 29, 2016, on the Computation and Funding of Terminal Leave Benefits and Monetization of Leave Credits, and CSC Memorandum Circular No. 02, s. 2016, on the Amendment to the Constant Factor in the Formula used for Computing Terminal Leave Benefits (Section 40) and Computation of Leave Monetization (Section 24) of the Omnibus Rules on Leave;
- The appropriation for Overtime and Night Pay in the amount of Eighty Six Thousand One Hundred Seventeen Pesos & 10/100 (P86,117.10) shall be in accordance with the guidelines of CSC-DBM Joint Circular No. 2, series 2015 dated November 25, 2015, on the Policies and Guidelines on Overtime Services and Overtime Pay for Government Employees;
- 3. The appropriation for Year-End Bonus in the amount of One Hundred Sixty Six Thousand Two Hundred Sixty Pesos & 30/100 (P166,260.30) shall be in accordance with the guidelines of DBM Budget Circular No. 2016-4 dated April 28, 2016, on the Updated Rules and Regulations on the Grant of the Year End Bonus and Cash Gift for FY 2016 and Years Thereafter;

RESOLVED FURTHER, to require the Municipality of Jones, Isabela to comply with the herein review findings and/or conditions.

RESOLVED FURTHERMORE, to inform the Municipality of Jones, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable NHEL C. MONTANO**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Jones, Isabela through the **Honorable EVELN R. RASPADO**, Municipal Vice-Mayor.
