A RESOLUTION DECLARING SPECIAL ORDINANCE NO. 016-2023 OF THE CITY LOCAL GOVERNMENT UNIT OF ILAGAN, ISABELA AS VALID

**Sponsor: HON. DELFINITO EMMANUEL L. ALBANO**Chairperson, Committee on Municipal Appropriations

WHEREAS, pursuant to Article 468(a)(i) of the Local Government Code, the Sangguniang Panlalawigan has the authority to "review all ordinances approved by the sangguniang of component cities and municipalities" and to "determine whether these are within the scope of the prescribed powers of the sanggunian";

WHEREAS, presented before this August Body is Special Ordinance No. 016-023 of the City Local Government Unit of Ilagan, Isabela (CLGU Ilagan) titled "Ordinance Authorizing the Proposed Borrowing of the City of Ilagan in the Amount of Nine Hundred Million Pesos (P900,000,000.00) with the Land Bank of the Philippines to be Used to Finance the Implementation of Various Infrastructure and Development Projects in the City of Ilagan";

Email add.: isabelasecretarysoffice@gmail.com pgi isabela.spsecretary@yahoo.com WHEREAS, as stated in the Ordinance, CLGU liagan will enter into a Loan Agreement with the Land Bank of the Philippines for the amount of Nine Hundred Million Pesos (P900,000,000.00) to finance their various infrastructure projects that are projected to bring about economic progress that will benefit all sectors in the community in their area;

WHEREAS, Section 297(a) of the Local Government Code allows local government units to contract loans, credits, and other forms of indebtedness with any government or domestic private bank and other lending institutions to finance the construction, installation, improvement, expansion, operation, or maintenance of public facilities, infrastructure facilities and the implementation of other capital investment projects, subject to such terms and conditions as may be agreed upon by the local government unit and the lender;

WHEREAS, this August Body recognizes that local government units possess direct information concerning the needs of their citizens and the conditions within their jurisdiction and thus are in the best position to identify the programs and projects that will advance the welfare of their people;

WHEREAS, after careful review and with due consideration to the recommendation of the Provincial Budget Office interposing no objection and stating no adverse finding to CLGU llagan Special Ordinance No. 016-2023, this August Body determined that the said ordinance is a valid exercise of the legislative powers of their sanggunian and within the authority of CLGU llagan as prescribed by law subject to compliance with the budgetary limitations for debt servicing as provided in Section 324 of the Local Government Code;

WHEREFORE, upon motion of Honorable Delfinito Emmanuel L. Albano, duly approved and seconded in a session duly assembled, it was —

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION DECLARING SPECIAL ORDINANCE NO. 016-2023 OF THE CITY LOCAL GOVERNMENT UNIT OF ILAGAN, ISABELA AS VALID
