WHEREAS, in consideration to the importance of the mandates and initiatives of the DOH-DATRC-R02, the PGI is willing and prepared to coordinate with DOH-DATRC-R02 as this will nourish the overall health and wellness of the Isabeleños towards a dynamic and socio-economically progressive Isabela;

WHEREAS, this August Body recognizes that drug abuse treatment and rehabilitation requires careful, attentive, and effective medical and aftercare services. As such, it must be accorded with appropriate attention and support to ensure the safety and effectiveness of the drug abuse treatment and rehabilitation;

WHEREAS, submitted for the review and approval of this August Body is the draft Memorandum of Agreement to be executed by the PGI and DOH-DATRC-R02 which seeks to establish a partnership and patient referral system for the patients of DOH-DATRC-R02;

WHEREAS, after a careful review of the Memorandum of Agreement this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

WHEREAS, Section 465 (b)(1)(vi) of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign on its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREFORE, upon motion of the Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was —
