ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT — FIELD OFFICE 02 AND THE CITY AND MUNICIPAL GOVERNMENT UNITS IN THE PROVINCE OF ISABELA FOR THE IMPLEMENTATION OF THE RISK RESILIENCY PROGRAM THROUGH THE CASH-FOR-WORK/TRAINING PROJECT

WHEREAS, Section 16 of the Local Government Code of 1991 empowers Local Government Units to exercise all powers necessary, appropriate, or incidental for the promotion of the general welfare of their people;

WHEREAS, taking into consideration the vulnerability of the Province of Isabela to the effects of climate change and natural disasters, the Provincial Government of Isabela adopts a disaster risk reduction and management approach that promotes the involvement and participation of all sectors and stakeholders concerned, at all levels, especially the local community in its disaster preparation, management, and recovery efforts;

WHEREAS, the National Government has designed the Risk Resiliency Program 2023-2024 to harmonize, complement, and synergize the efforts of National Government Agencies (NGAs) and other government instrumentalities, through the Climate Change Adaptation, Mitigation, and Disaster Risk Reduction Cabinet Cluster (CCAM-DRR Cluster), in delivering the national vision on climate change adaptation, mitigation, and disaster risk reduction;

WHEREAS, the CCA-DRR Cluster has adopted the cash-for-work/training scheme in extending social interventions to poor families in disaster-affected communities;

WHEREAS, the National Government has allocated funds to the Department of Social Welfare and Development for the implementation of the Risk Resilience Program through the Cash-for-Work/Training Project;

WHEREAS, in line with the objectives of the Risk Resilience Program in promoting coordination, consultation, and collaboration among NGAs and other government instrumentalities in implementing climate change adaptation and disaster-resiliency policies, the Department of Social Welfare and Development – Field Office 02 (DSWD – FO2), the Provincial Government of Isabela, and the City and Municipal Government Units in the Province of Isabela seeks to enter into a partnership for the implementation of the Risk Resilience Program through the Cash-for-Work/Training Project;

WHEREAS, submitted for the review and approval of this August Body is a letter from the Office of the Provincial Governor requesting that the Provincial Governor be granted with authority to enter into a Memorandum of Agreement (MOA) with the DSWD – FO2 and City and Municipal Government Units in the Province of Isabela for the implementation of the Risk Resilience Program through the Cash-for-Work/Training Project;

WHEREAS, this August Body recognizes the effectiveness of cash-forwork/training programs in facilitating the implementation of government programs for disaster preparation and management in disaster-stricken areas by encouraging the involvement and assistance of the disaster victims in the recovery and rehabilitation efforts through monetary incentives; A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, THE HONORABLE RODOLFO T. WHEREAS, after careful review, this August Body determined that the proposed MOA to be entered into by the Provincial Government of Isabela, DSWD – FO2, and City and Municipal Government Units in the Province of Isabela is just and lawful and that granting the Provincial Governor the authority to sign the same to be beneficial to the Isabeleños;

WHEREAS, Section 465(b)(1)(vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREFORE, upon motion of the Honorable Victor G. Dy, duly approved and seconded in a session duly assembled, it was -

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, THE HONORABLE RODOLFO T.
