WHEREAS, the Office of the Vice President (OVP) aspires to partner with the Provincial Government of Isabela (PGI) in implementing its medical assistance program in the Province of Isabela;

WHEREAS, to facilitate the grant of medical assistance to the beneficiaries of the OVP's medical assistance program, the OVP seeks to establish a credit line at the Governor Faustino N. Dy Sr. Memorial Hospital, a hospital owned and operated by the Provincial Government of Isabela;

WHEREAS, submitted for the review and approval of this August Body is the proposed Memorandum of Agreement to be entered into by the Provincial Government of Isabela and the OVP for the establishment of a credit line for the OVP at the Governor Faustino N. Dy Sr. Memorial Hospital with a concomitant request from the Provincial Governor that he be granted with authority to sign the said MOA on behalf of the Provincial Government of Isabela

WHEREAS, after careful review, this August Body determined that the said proposed MOA for the establishment of a credit line for the OVP at the Governor Faustino N. Dy Sr. Memorial Hospital, which shall be used in extending assistance to qualified dialysis patient beneficiaries of the OVP medical assistance program who received dialysis services from such hospital, to be just and lawful and that granting the Provincial Governor the authority to sign the same on behalf of the Provincial Government of Isabela to be beneficial to the Isabeleños;

WHEREAS, Section 465(b)(1)(vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREFORE, upon motion of the Honorable Edward S. Isidro, duly approved and seconded in a session duly assembled, it was -

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, THE HONORABLE RODOLFO T.
