ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT AND A DEED OF DONATION FOR THE DONATION OF ONE (1) UNIT ISUZU FREEZER VAN IN FAVOR OF THE SAN PABLO ISABELA FARMERS DAIRY COOPERATIVE AND ESTABLISHING THEIR RESPECTIVE OBLIGATIONS IN IMPLEMENTING THE ENHANCED KADIWA INCLUSIVE FOOD SUPPLY CHAIN PROGRAM

WHEREAS, the Department of Agriculture is the executive department of the Philippine government responsible for the promotion and development of the agriculture and fishery sectors;

WHEREAS, in line with their agriculture promotion mandate, the Department of Agriculture implemented the Enhanced KADIWA Inclusive Food Supply Chain program. Under this program, financial grants are provided to eligible farmer and fisherfolk cooperatives and associations (FCA) to enhance their capacities to become reliable food commodity suppliers to consumers and for community based-organizations;

WHEREAS, the Department of Agriculture and the Provincial Government of Isabela have agreed to allocate funds, in the total amount of Php12,360,000.00 and Php2,060,000.00 serves as the PGI's counterpart, to ensure the effective implementation of the said program in the Province of Isabela;

WHEREAS, the said total amount was utilized to purchase hauling trucks, delivery vans, and freezer vans to be used as transport services for the marketing of agricultural and fishery products of various farmer cooperatives and associations (FCAs) in the Province of Isabela:

WHEREAS, the San Pablo Isabela Farmers Dairy Cooperative is among those duly recognized FCAs determined to be eligible to receive assistance under the said program. As such, a one (1) unit Isuzu Freezer Van will be donated in their favor subject to their execution of a Memorandum of Agreement and a Deed of Donation with the Provincial Government of Isabela;

WHEREAS, submitted for the review and approval of this August Body is the proposed Memorandum of Agreement (MOA) and Deed of Donation to be entered into by the Provincial Government of Isabela and the San Pablo Isabela Farmers Dairy Cooperative. The MOA establishes the obligations of both parties in implementing the said program while the Deed of Donation will effectuate the donation of the said freezer van;

WHEREAS, Section 465(b)(1)(vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, after careful review of the said documents, this August Body deemed such to be just, lawful, and in line with the agriculture promotion policies of the Provincial Government of Isabela. Accordingly, it concurred to grant the Provincial Governor the necessary authority to sign the same on behalf of the Provincial Government of Isabela;

WHEREFORE, upon motion of the Honorable Adrian Philip S. Baysac, duly approved and seconded in a session duly assembled, it was -
